# PRIVACY POLICY U-DRIVERS SP. Z O.O – GDPR

This privacy policy explains the rules and scope of processing the User's personal data, their rights and our obligations as the Data Administrator. This also constitutes the fulfillment of the obligations of U-Drivers Sp. z o. o. as the Administrator specified in art. 13 and 14 of Regulation (EU) 2016/679 of the European Parliament and of the Council (EU) of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation) (hereinafter: GDPR).

# 1. The Data Administrator is:

**U-DRIVERS SPÓŁKA Z OGRANICZONĄ ODPOWIEDZIALNOŚCIĄ**, with its registered office in Warsaw, Krucza street 16/22, 00-526 Warsaw, entered in the Register of Entrepreneurs, kept by the District Court for the capital city of St. Warsaw, XII Commercial Department of the National Court under 0000989673, NIP 7011103753 (hereinafter referred to as the "Administrator"). The administrator has appointed a Data Protection Officer (hereinafter referred to as the "DPO").

### 2. Contact with the Data Protection Officer and in matters of personal data

### 3. Personal data processed by the Administrator

1) Method of obtaining personal data.

The Administrator obtains personal data directly from the User through the Website, through the functionalities and tools available on it communication and sending messages to the Administrator through them. Providing personal data by the user is voluntary.

2) Types of processed personal data

The Administrator collects the following personal data via the Website:

- 1. Name and surname;
- 2. Telephone number.

3) Providing personal data is voluntary, but necessary for communication with User, which involves the processing of personal data for purpose described below.

# 4. Purposes of personal data processing

The method of processing User data by the Administrator depends on the way the User uses the Website and available on it functionalities. The Administrator processes the User's personal data in for the following purposes:

1) Communication with the User. The Administrator uses the User's personal data to communicate with him in a personalized way. The information communicated to the User concerns products or services offered, security of personal data, updates network, reminders, but also suggested offers of the Administrator or his partners. Communication with the User also applies to the User's service. Personal data is use to help the User, the solution technical problems and responses to his complaints or complaints.

2) Presenting commercial offers to the User electronically and on the phone. The purpose of using the User's personal data provided by him through the functionalities and communication tools available in the website is marketing communication conducted by the Administrator in as part of the conducted activity, in particular presenting offers commercial information to the User by e-mail and by telephone.

The Administrator may process the User's personal data obtained for via the Website also for the following purposes:

1) in order to conclude and implement a possible contract between the User and Administrator and servicing the User as a client of the Administrator in accordance with article 6(1)(b) GDPR;

2) in order to conduct financial settlements with the User who is a customer Administrator for the implementation of a possible contract concluded between the parties, also possible pursuit of claims from the User who is a customer as part of the legitimate interest of the Administrator in accordance with Art. 6 sec. 1 lit. f) GDPR and fulfilling the Administrator's legal obligations towards tax authorities on the basis of separate provisions in accordance with art. 6 sec. 1 lit. c) GDPR;

3) in order to implement the Administrator's marketing activities within the legal framework the legitimate interest of the Administrator within the meaning of art. 6(1)(f) GDPR, and also in accordance with declarations of will regarding marketing communication submitted to the Administrator. Communication consents marketing (e.g. for sending commercial information by electronic means or telephone contact for direct marketing purposes) may be withdrawn in at any

time, without affecting the lawfulness of the processing was made on the basis of consent before its withdrawal;

4) in order to fulfill the Administrator's legal obligations towards the User specified in the GDPR, within the meaning of art. 6(1)(c) GDPR.

# 5. Providing personal data

1) Collected personal data may be made available to employees and associates. Administrator only to the extent that it is necessary for them to provide the service ordered by the Administrator.

2) The User's personal data is not transferred by the Administrator to entities third.

3) The Administrator ensures safe processing of the User's personal data using effective and appropriately tailored technical and organizational measures.

# 6. User Rights

1) The User has the right to access their data, rectify it and supplements, objections, data transfer, restrictions processing, and request their removal by contacting <u>business@u-drivers.ua</u>. If you do not agree to the above, please send your objection to in writing to the address of U-Drivers sp. z o.o. Krucza st. 16/22, 00-526 Warsaw.

2) The User whose personal data is processed by the Administrator has the right to lodge a complaint with the supervisory authority competent in matters of data protection personal data (President of the Office for Personal Data Protection) if it is recognized that that the processing of personal data violates the provisions of the GDPR.

### 7. Duration of storing personal data

The User's data will be processed until the purpose for which they were harvested.
